



## CONTESTANT RULES & REGULATIONS

### MAIN LINE BROADCASTING – WBBT / WLFV / WWLB

THE FOLLOWING GENERAL CONTEST RULES APPLY TO ALL WBBT / WLFV AND WWLB CONTESTS, DAILY FEATURES, SHORT TERM CONTESTS AND ALL CONTESTS THAT DO NOT HAVE SEPARATE CONTEST RULES.

NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

#### Eligibility Restrictions:

- Employees of Main Line Broadcasting, their affiliated entities, its affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Richmond, Virginia Metro area and members of their immediate families are ineligible to enter or win.
- Must be 18 years of age unless otherwise specified.
- Only one winner per household can win a prize within a 30 day period.
- An individual can only win a prize from any of our Main Line Broadcasting radio stations once within 30 days.
- Failure of to sign the affidavit or release, failure to claim a prize within 30 days of the station notifying the winner of prize availability, or failure to comply with any term or condition of these Official Rules, may, at the sole discretion of Main Line Broadcasting, result in winner's disqualification, the forfeiture of his or her interest in the prize.
- Social Security Numbers (SSN) must be collected at time of prize pick-up. If a winner collects \$600 or more in prize value overall through a calendar year, that contestant will then be issued a 1099 Form. All information, including SSN's, is for Accounting/IRS purposes only and never given out or sold.
- All contest winners need to give their full name upon winning. Contestants may not call and give someone else's name to claim the prize. Non compliance with this rule may result in disqualification of contest/prize.

**General Rules:**

- All entrants and winners agree that the station may broadcast or publish their name, city of residence, photo, video tape, film or any other likeness, including their voice, recorded or live, for any reason the station deems necessary without compensation. All entrants further agree to hold the station blameless and without liability for such publications, broadcast or use.
- All entry blanks, forms devices and materials, as well as all the information contained on or within, gathered during the course of entry, shall become the sole property of the station to be disposed of at their discretion of the station.
- The station reserves the right to limit the number of times an individual may enter a contest or drawing.
- The station reserves the right to require contestants to be present at drawings in order to win their prize.
- The station reserves the right to modify a contest/promotion at any time without prior notification.
- The station reserves the right to suspend or terminate a contest/promotion at any time with prior notification.

**Prizes:**

- Prize is nontransferable and cannot be exchanged for cash.
- All state, local, federal and other taxes, duties, tariffs, title fees, licensing fees or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize(s) valued at over \$600 will be issued an IRS form 1099 to report their winnings.
- Main Line Broadcasting shall not be responsible for the failure of participating sponsors to deliver prizes as promised.
- All entrants and winners agree that the station, Main Line Broadcasting and their affiliates, shall have no liability and shall be held blameless for any injury, misfortune, or damage to either persons or property insured by entering, participating in, winning or losing any contest by use or not-use of any prize received.

**Reservation of Rights:**

By participating in this Contest, contestants agree to be bound by these Official Rules and the decisions of the Contest supervisors and judges. Main Line Broadcasting reserves the right to disqualify persons found tampering with or otherwise abusing any aspect of this Contest as solely determined by WBBT, WLFV, AND / OR WWLB. In the event the Contest is compromised by tampering or other causes beyond the reasonable control of Main Line Broadcasting which corrupt or impair the administration, security, fairness or proper operation of the Contest, Main Line Broadcasting also reserves the right in its sole discretion to suspend or terminate the Contest. Main Line Broadcasting reserves the right to modify the Contest or these Official Rules.
